# Sandvik Sustainability & Circularity Goals

#### Net Zero CO<sub>2</sub>e emissions by 2050

We have set clear targets to reduce our climate impact and reach net-zero, consistent with the goals of the Paris Agreement to limit global warming to 1.5°C.

- Reduce absolute scope 1 and 2 GHG emissions by 50% by 2030\*
- Reduce absolute scope 3 emissions by 30% by 2030
- Reduce absolute scope 1 and 2 GHG emissions by 90% by 2040\*
- Reach net-zero GHG emissions across the value chain by 2050

#### Circularity

We will drive circularity and resource efficiency, doing better with less and working towards circular value chains.

More than 90% circularity by 2030

#### **Operations**

At least 90% material circularity for:


- Packaging
